JURIED SHOW

(ENTRY DEADLINE: JUNE 1)

The Juried Show is entered by submission of a JPEG file (email or CD*) of artwork and meeting all eligibility and exhibition conditions as stated herein.

ENTRY PROCEDURES:

- All juried entries must be submitted as a JPEG.
- \$35 for up to 3 entries.
- Judges will select artwork for the Juried Show from the entry JPEGs. Artwork not selected for the Juried Show will be placed in the Open Show without additional fee and the artist will be notified of judges' decision by the mailed return of labels.
- Artwork which differs from the submitted JPEGs will not be shown in the Juried Show. Artist may not substitute another work for accepted work, nor alter the work or the price.
- We will send labels to be affixed to your designating entry into the Juried Show or Open Show.
- Delivery of artwork according to Calendar of Events.
- Adherence to all exhibition conditions.

CDs & JPEGs:

- Digital entries should be sent as a 72dpi JPEG file (*minimum* dimension 6 inches) on a 'PC platform CD' or by email.
- Sculpture entries may submit more than one view of work.
- Entries must be labeled with artist name, title, medium, and size of work.

MAIL THE FOLLOWING:

- Completed and **signed** entry form. *Juried box **must** be checked for consideration in the Juried Show.*
- JPEG CDs (or emails) ONLY, NO slides. CD's will not be returned.
- \$35 entry fee (check or money order payable to KA&C). Entry fee is non-refundable.
- A #10 (long) self-addressed, stamped envelope for the notification form, labels and instructions.

OPEN SHOW

(REGISTRATION DEADLINE: JULY 1)

The Open Show is entered by meeting the eligibility and exhibition conditions as stated herein. **You must pre-register to enter.**

ENTRY PROCEDURES:

- \$30 for up to 3 entries.
- Completed entry form and SASE.
- We will send labels to be affixed to your artwork as proof of pre-registration.
- Delivery of artwork according to Calendar of Events.
- Adherence to all exhibition conditions.

MAIL THE FOLLOWING:

- \$30 entry fee (check or money order payable to KA&C). Entry fee is non-refundable.
- Completed and **signed** entry form.
- A self-addressed, stamped envelope (#10 – long).

SATELLITE DELIVERY and PICK-UP

Artists living east of Puget Sound may deliver their pre-registered 2-D work to this alternate site. *Sculpture entries are not eligible for satellite pick-up; they must be delivered to Kingston.* All 2-D work **must be packed for transport** in large, flat, cardboard boxes with handholds cut into the sides. If more than one painting per box, separate with cardboard. Label boxes with your name. No towels or blankets, please. **Artwork not properly packaged in cardboard will not be accepted.**

RULES AND CONDITIONS

ELIGIBILITY:

- Open to all artists in the Western United States and Western Canada 18 years or older. All two and three dimensional mediums are eligible.
- Original artwork only, entirely the work of the entrant, and completed within the last two years without the supervision of an instructor.
- Entries must not be copies, derivatives, or based on other copyrighted works. Artist may enter both the Juried and Open Shows, any media, **but no more than 3 entries overall.** KA&C Association reserves the right to refuse any work.

EXHIBITION CONDITIONS:

- Artwork and Photography must be substantially framed and ready for hanging with strong wire. No brackets, exposed glass edges or self-adhesive hooks are permitted. Artwork *may not exceed 48 inches in width or length, including frame.* Photography: maximum print size 20"x 24", not including mounting or matboard. All two-dimensional works on paper must have glass or plexiglas.
- Sculpture must be solid-standing or securely mounted. Sculpture must be hand-delivered to show site.
- *All artwork **must** be for sale and priced with the intent to sell.* KA&C Association will deduct a 25% commission on all show sales. Artists are responsible for reporting and paying their own sales tax.
- KA&C Association reserves the right to photograph entries for publicity and promotional purposes.
- All artwork *must* remain until the end of the show, August 2, Sunday at 5 p.m.

LIABILITY:

- Artists assume all liability for their entries and are encouraged to carry their own insurance.
- While every precaution will be taken to avoid damages, the KA&C Association, its officers, members, volunteers, or anyone connected with the exhibition will not be responsible for any loss or damage incurred.

AWARDS:

- Cash awards will be given in Art, Sculpture, and Photography in both the Juried and Open Shows; a Best of Show award will also be given.
- Awards will be given at the judges' discretion. The decisions of the judges are final.
